4. FIRST AID MEASURES

5. FIREFIGHTING MEASURES

7. HANDLING AND STORAGE

Equipment construction material should be compatible with feed, regenerant, ionic form and effluent of the ion exchange process. Avoid contact with eyes. Avoid generating and breathing dust. Wash thoroughly after handling. Keep container closed. Good housekeeping and controlling of dusts are necessary for safe handling of product.
