THE CHALLENGE

A large Northern California refinery struggled to maintain production through seasonal water changes while hot weather increased cooling tower evaporation.

The plant's raw water quality changed drastically as the surface water source experienced turbidity and inundation with excess organics.

These seasonal changes overtaxed the existing water treatment system clogging pretreatment equipment and negatively impacting reverse osmosis (RO) reliability and quality.

The struggling water treatment system couldn't keep up with the plant's water demands and reduced production capacity.

THE SOLUTION

The customer needed an emergency solution and Puretec delivered within 24 hours.

We installed 630 cubic foot, 10 million grain Mobile Deionization (MODI) trailers to treat 200 gpm of raw water and effectively supplement the plant's low RO throughput.

With the emergency issue addressed, Puretec added temporary 45 cubic foot carbon service vessels to further improve filtration by reducing organics and color.



EFFECTIVE & ON-DEMAND

Immediate action and highly effective mobile water treatment solutions allowed the refinery to maintain production with no disruption.

Once the seasonal surface water quality issues resolved, Puretec's mobile treatment equipment was disconnected, and the client returned to their in-house water purification processes.

The client's satisfaction and successful production schedule resulted in an extended contract to continue refinery support and similar support for the customer's other plant in Southern California.
